2 Steps of De-Registration- TIN and Tax Type

Step 1: Log in Screen

A taxpayer should Log-in through Dhareeba where a taxpayer is automatically directed to NAS (to know how to Sign-up please refer to the document: GTA_TAS_Self Registration on National Authentication System).

NOTE: "FAQ" and "Taxpayer Guide" are available under the "Help" tab.



Taxpayer should enter QID or Email address as 'Username' and its associated password and click on "Continue" button after providing the login credentials.

In case of Excise Tax:

If the taxpayer chooses the reason for the cancellation of the excise tax registration, for example "Cessation of production and/or import of excisable goods ", a button will appear to upload the supporting documents to choose this reason.



The taxpayer moves on to the second step: tax information Also shown in the screen below are some fields that are not amendable and track the original taxpayer's registration in excise tax.



The taxpayer selects the date of deregistration. And choose the answer to the question Do you have any operations outside the warehouse? If "No", the taxpayer goes to the contact person's screen. If he selects "Yes", he will be taken to the "Item Details" screen
